## INDIVIDUAL CLAIM FACILITATION CELL

### **PURPOSE:**

The purpose of the cell is to practically establish the individual claim facility given as a basic right of all global individuals through the UNIVERSAL DECLARATION OF HUMAN RIGHTS. Each and every article in the Universal Declaration of Human Rights is drafted addressing to the global population individually, like, "Everyone, No one, etc." and also the preamble of the Universal Declaration of Human Rights states that "THE GENERAL ASSEMBLY proclaims THIS UNIVERSAL DECLARATION OF HUMAN RIGHTS as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction." Hence an individual specific approach towards the UDHR is very much important.

### **FUNCTIONING:**

The Individual Claim Facilitation Cell (ICFC) will make all possible efforts to make every single individual of on this earth live a peaceful, satisfied, prosperous and purposeful life by applying their right as responsibility which is native to them by birth. For this the cell will initiate all possible measures to facilitate a claim made by any individual in line with the rights vested to them under the Universal Declaration of Human Rights through their respective government to make the rules enacted progressively for a better living environment fostering fraternity.

The cell will carry out its functioning in the following manner,

(i) Any individual from any part of the world can make their communication to the cell through writing which can be sent either through mail or through post whichever is comfortable and accessible by the sender.

- (ii) Emails addressed to the zonal office will be copied to the perusal of the Executive Chief immediately. After receiving the communication, the head of the associate panel in the respective zone will go through the communication mail and then the necessary background details and research will be done and reported to the Executive Chief where the solution will be sorted out and the necessary communication with the individual and the government will be made by the executive chief.
- (iii) If the communication is received through post, the registrars in each zonal office will convert the hard copy received into a soft copy which will be mailed to the zonal representatives of the associate panel and the Executive Chief by the registrar as early as possible and the entire communication from there to the government will be made online as per the functioning procedures. The status will be visible to the individual having him as a part of the procedure all through. The final solution will also be communicated to the individual in the same procedure.
- (iv) Further the cell will analyze the claim received and would check the genuinity of the claim made by the individual in line with the rights vested. If the claim is legally genuine according to the Universal Declaration of Human Rights, the cell will communicate to the respective government and will regulate the government to facilitate the opportunity claimed for the growth and living of the individual with due conviction of all involved. An option progressive and apt as per rules and which is not known to the individual may also be suggested for the understanding of the individual to choose the best of comfort to his originality permitted by norms. This is absolutely essential and remains transparent for it helps the civic grow with skills polished for best of performance.

The status of the claim will be open until the claimer registers his satisfaction about the purposeful facilitation of the claim made. If the claim made by the individual is in a way to build or promote discrimination among the global population or if the claim made would hurt the living of any other individual or if the claim made violates the human rights or if the claim made is contrary to the basic principle of the organization (global unity and peace), the cell will revert back to the individual explaining him with the injustice present in his claim and the cell would communicate to the respective individuals any number times until the individual is soulfully convinced with reply because creating conviction is essential to re-orient the individually progressively.

In this case, the individual must be inquired with the problem he is facing and the cell would help him in solving the problem by suggesting him with all possible alternatives in line with human rights. Therefore the individual can claim by choosing any one from the alternatives communicated to him or he can come forward with his own alternative which is in line with the rights vested.

### For example;

- An individual "A" communicates to the cell claiming for an educational opportunity which was either denied to him or ignored by the system. Then the cell will proceed communicating to the organization asking for the reason whose copy will be made to the respective government. After receiving a formal reply from the organization the cell will look into the violations made and the valid opportunities which was denied to the individual and would regulate the organization convincingly through the government and this claim will be in open status until the cell receives a reply from the individual stating his satisfaction regarding the facilities facilitated to him for his claim.
- An individual "B" communicates to the cell claiming for a separate country or regime which is against the right and principles of the Constitution of the country. The cell will now communicate with the individual asking for the reason for his claim and if he reverts back stating that there is no equality given to a specific group in their country's governance which is also a violation of human rights, the cell will further the process by communicating back to the individual stating that he cannot claim for a separate country as it would further divide the world into several fragments and would increase the enmity among the nations. The cell will also convince the individual with all facilities that are available to them according to their constitution and type of governance and the difficulties that they would face after the separation. Simultaneously, the cell will also communicate to the government of the country after analyzing its functioning and practices of the nation, the cell will suggest with the essential reformations needed in the functioning of the government in order to facilitate equal opportunities and equal recognition to all its citizens. The best alternate ever proposed by the human rights is individual right to live and that alone can be claimed through the OHCHR. As per stipulated norms of the organization, it would strive to establish only the right to live of an individual.

- (v) The final solution sort out for the individual will be copied to the head of the associate panel where he can follow and check with the practical implementation of the solution facilitated with the individual and the government.
- (vi) At the end of the process the associate panel must receive an satisfaction receipt from the individual communicated regarding his claim.
- (vii) This cell can also train the regional and zonal offices of OHCHR on how to progressively approach the day to day happening of the region in line with human rights by which the zonal offices of the OHCHR can understand and guide the National and State Human rights commission of the countries in their respective zones with the correct way of approaching their activities facilitating human rights. Human rights are not a vested position, it is responsibility claimed by an individual for his abilities and weaknesses that he could establish fraternity for his might. He could avoid conflicting situations with rules. The gap between the worldly affair and rules are too big that they almost run parallel in the recent times making the civic loose hope to remain skillful. The confidence level is not righteous, but more pronounced as authority in several places and less pronounced as ignorance in certain places. Self esteem and dignity is not an average position claimed for the reservations, but for the comfort level one may get and wish to further with his own strength and weaknesses.

#### **DO'S AND DON'TS OF THE CELL:**

(i) The cell will encourage and process every single communication made to them in any mode. The basic focus of the cell will be to facilitate or accomplish human rights vested to every single individual through Universal Declaration of Human Rights practically as responsibility and self esteem. The procedure of governing body, the leadership quality in any mode of regime from monarchy to democracy through constitutional monarchy and republic, need to promote simplicity and should not remain simplistic giving formats and authority as authenticity that would make people hesitate to approach.

- (ii) The cell cannot ignore or reject any communication made to it at any circumstance. Once the cell receives a claim from an individual the cell must take all possible measure to free the individual from the problem faced at the end.
- (iii) Every claim made by the individual to the cell must be addressed and cleared at the earliest. There must be adequate space for trustworthiness and transparency to promote inclusion and belief of an individual towards truth and ethics,.
- (iv) The cell must revert back to the individuals immediately with a confirmation message of receiving and registering their communication made. It must also affirm them with that their claim will be addressed by the cell as early as possible with due justice and conviction and make them inclusive to participate in the progression.
- (v) Every communication received must be given due concern immediately and equally without any partial importance. Even the small claim made by an individual must be given due concern and significance. There need to be due advertisement for the participation of public with their right to express and that doesn't mean they ought to be accepted but ought to be addressed as per human rights declaration. Every bit of communication in social forum too need to be to understand and permit the individual right to live with an assurance to progress with his own potential enhanced based on his interests. This needs contribution of officials mindfully to promote the environment progressively. By this on line communication, it is very easy to establish what human rights is as responsibility of an individual and that regulates group activities and NGOs.
- (vi) The individuals can communicate to the cell directly and the cell will take utmost care in creating due conviction with all involved in the issue.
- (vii) There is no specific format to communicate the cell with the claim. Individuals can communicate without any restriction in the comfortable manner and the only thing that is mandate in the details of the individual communicating. The voice mail facility can be enacted that they can get due assistance for translation that their status as human being or creation of nature forms the base.

- (viii) All the general claim made which is facilitated to the citizens through a public organization, institution, agency or association will not only be regulated addressing the issue in specific for the individual but the cell will regulate the facility facilitated such that no other individual will suffer from the same violation again.
- (ix) No one working in this cell must employ authority in any form. There must be due place given for inclusion to whoever approaches the cell for help or guidance. Proper guidance and concern must be given to all communications made to the cell. The motto should be "Get more than what you expect".
- (x) The cell must make it a point to check that at every level and at the end of every process conviction is created among all the individuals involved as the basic goal and vision of the organization is to achieve global unity and peace which is possible only when there is conviction and peacefulness in the mind and soul of all individuals.

### **ZONAL OFFICE OF THE ICFC CELL:**

The ICFC cell will have its office in 7 zones and the seven zones are follows, (i) The Americas, (ii) North Africa, (iii) South Africa, (iv) North West Eurasia, (v) East Asia, (vi) South West Asia, and (vii) South East Australasia.

The countries that will be included in the zones are as follows,



## **DUTIES AND RESPONSIBILITIES OF OFFICIALS:**

#### 1. EXECUTIVE CHIEF:

- The executive chief of the cell is the head of the cell who will review all the communication made to and from the cell on daily basis.
- Any communication made by the cell will include the executive chief as a part..
- The executive chief will come under the purview of the High Commissioner of human rights.
- The executive chief will convey the violations and regulations made in the functioning of a country to the periodic review committee which would check the maintenance of the reformation made in that country during its review. As the governance head of the country is changing periodically, this facilitates the organization of UN to check the practicality and the degree of execution given by the government to reformations suggested to it by the cell.

• Each designation bears absolute self responsibility and they can move beyond boundaries of the job responsibilities to create conviction. The official decorum is healthy participation without hierarchy assuring dignity and self responsibility of every individual.

### 2. ASSOCIATE PANEL:

- The associate panel will be appointed by the executive chief and there are no eligibility criteria for applying to this post according to article 8 of the United Nations Charter. This need to get extended to all governments of member countries and can happen in reality if UN move forward breaking the authoritative governing principles that had been inherited all along till this time.
- The duty of the associate panel is to help the executive chief with references and the facts that are needed to make the needed reformations.
- The individuals in the associate panel are responsible for the field research that needs to be done to address a claim made.
- The associate panel will consist of twelve members including the head of the associate panel. The associate panel will be set for each zone of the cell.
- The individuals working in the associate panel will be facilitated with the online job opportunity.

#### 3. REGISTRARS:

- The registrars will be appointed by the head of the associate panel in each zone respectively and again there are no eligibility criteria for applying to this post under article 8 of the United Nations Charter.
- The duty of the registrars is to convert all the documents received as a hard copy to soft copy.
- The registration crew will have five members and each zone of the ICFC cell will have registrars appointed for them individually. The registrar will work from the regional office of the ICFC cell.

The national and state human rights commission can be relieved from the government and get attached to this cell to act as third party agency to audit equality in providing opportunities to all that will ensure skill development and mindful contribution of all concerned.

All across the world, the criteria set forth to establish amity and peace is preventive vigilance. It is in establishing the rule for the conviction and regulation with self actualization and the same can never be punitive or investigative. The investigative department need to have a closure converting them to counseling for the activity will come to public assessment if given due space to mature as government norms or the claims. This puts an end to terrorism and there cannot be intersection of interests by government and they can contribute their might voluntarily as suggestions or extend their help on request with authentication and the same cannot be a space for authority or power. Global governance will then be easy towards reforming the nations to natural boundaries which is a must to promote global growth in line with nature and that curbs the disasters to a great extent.
